Vontobel Fund – TwentyFour Absolute Return Credit Fund

Vontobel Fund - TwentyFour Absolute Return Credit Fund is managed by TwentyFour Asset Management LLP and is a Sub-Fund of the Vontobel Fund, a Luxembourg authorised SICAV. The Fund has been entered into the UK temporary marketing permissions regime.

Fund Objective

The investment objective of the Fund aims to achieve a positive absolute return in any market environment over a period of 3 years while keeping a modest level of volatility.

Investment Approach

The Fund is actively managed and will seek to achieve its investment objective by investing mainly in Investment Grade bonds and similar fixed income and floating rate securities. Up to 33% of the Fund's assets can be exposed to fixed income securities issued or guaranteed by government, government-related and supranational issuers or to high yield bonds. The Fund is not managed in reference to any benchmark index.





Rating Breakdown





Geographical Breakdown



Additionally, where no rating has been requested, or there is insufficient information on which to base a rating, a rating agency may assign a rating of NAA as the highest to D as the lowest credit quality. For unrated sovereign issues TwentyFour will adopt the issuing sovereign's credit rating. The average credit quality (ACQ) is provided to indicate the average credit rating of the portfolio's underlying investments' rating and may change over time. The portfolio itself has not been rated by an independent rating. For unrated bonds and cash and equivalents, when calculating the ACQ ratings TwentyFour will determine an internal rating by considering all relevant factors, including but not restricted to, the relationship between the bond's maturity and its price and/or yield, the ratings of comparable bonds, the issuer's financial statements and the issuer's credit rating if available. The risk of default increases as a bond's rating level of risk from lower-rated bonds. The ACQ may be lower if cash and equivalents are excluded from the calculation.
