Vontobel Fund – TwentyFour Sustainable Short Term Bond Income is managed by TwentyFour Asset Management LLP and is a Sub-Fund of the Vontobel Fund, a Luxembourg authorised SICAV. The Fund has been entered into the UK temporary marketing permissions regime.

Fund Objective

The investment objective of the Fund is to achieve a positive total return over a 3-year period whilst maintaining an annualised volatility of no more than 3%.

Investment Approach

The Fund mainly purchases securities of companies around the world that contribute to sustainable economic activity and will be screened in accordance with the Investment Manager’s view of appropriate sustainability principles. The Investment Manager will seek to avoid investments in companies with material production in tobacco, alcohol, gambling, adult entertainment, controversial weapons and carbon intensive industries, and companies involved in animal testing for cosmetic purposes. This list is not exhaustive and may change from time to time to reflect new developments and research in the field of sustainable investment.

ESG Integration Policy

The Fund considers environmental, social and governance (ESG) factors in the investment process, utilising an integrated approach.

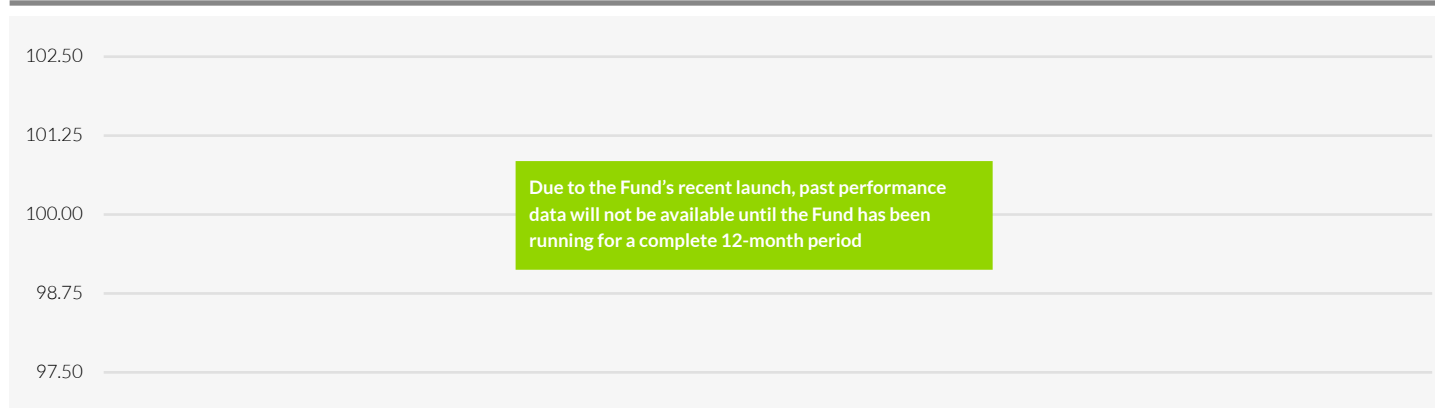

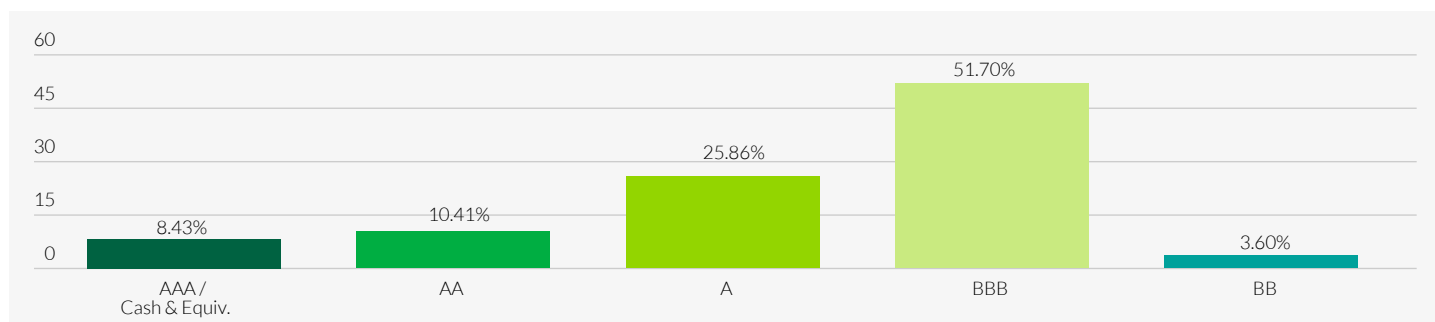

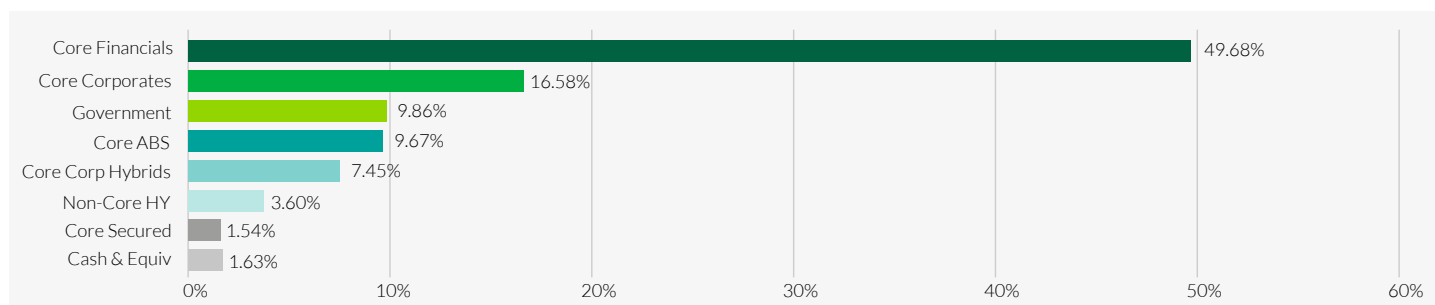

Rating Breakdown

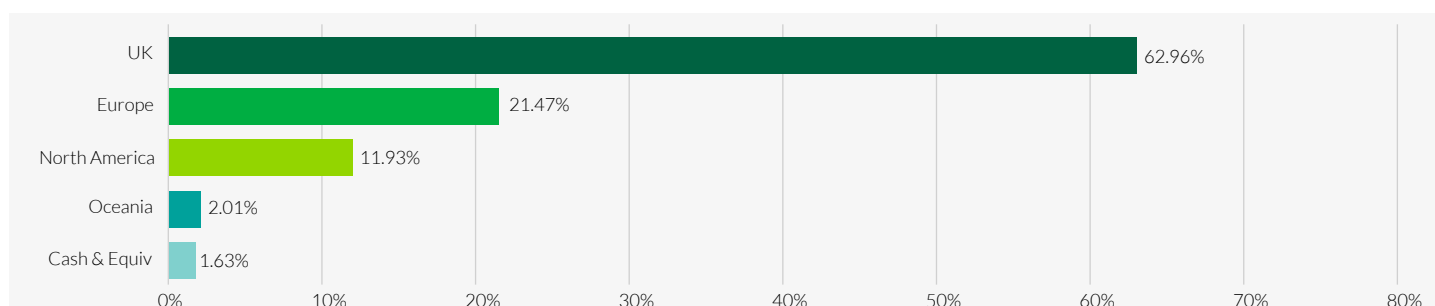

Sector Breakdown

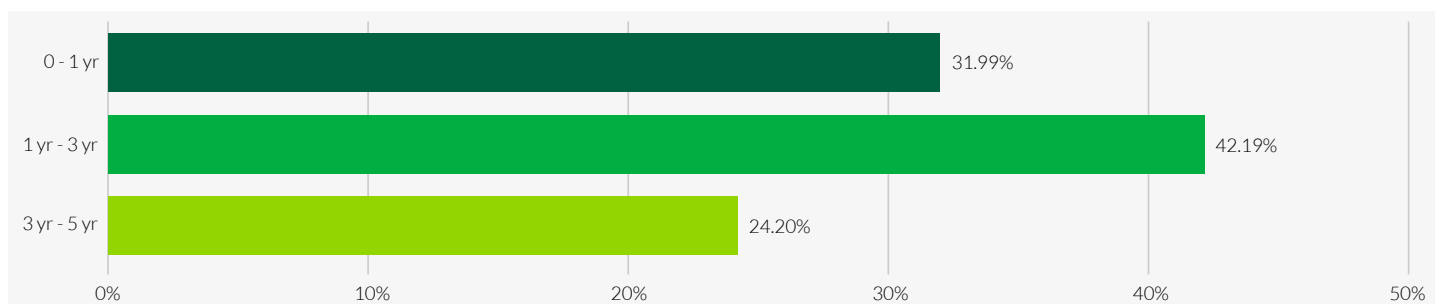


Geographical Breakdown
